DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-055)

WHEREAS, Purchase Request No. 2023-01-016 (Annex A) was received on 24 January 2023 for **PROCUREMENT OF VARIOUS CONSTRUCTION MATERIALS AND ELECTRICAL SUPPLIES** (the "Project") with approved budget for the contract in the amount of **NINE HUNDRED FIFTY THOUSAND PESOS (Php 950,000.00)**;

WHEREAS, the Project was publicly bid out in five (5) lots and awarded except Lot 1 or "**Supply and Delivery of Ceiling Materials**",

WHEREAS, Lot 1 or "**Supply and Delivery of Ceiling Materials**", was publicly bid out again on 3 March 2023 but was declared a failure of bidding for the second time, prompting the Bids and Awards Committee to recommend the change of mode of procurement to Negotiated Procurement - Two Failed Bidding in accordance with Section 53.1 of the implementing rules and regulations of Republic Act No. 9184;

WHEREAS, Request for Quotation AMP No. 2023-32 was posted in PhilGEPS on 31 March 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 31 March 2023, invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;

WHEREAS, on or before the deadline to submit quotation/s- 5 April 2023, 12NN - the following quotation/s was received and opened (Annex D is Abstract of Quotation):

WHEREAS, after verification and validation of all accepted proposals (Annex E is Evaluation Report), it was determined that the quotation of **Clearshot Builders, OPC** in the amount of **NINE HUNDRED FIFTY THOUSAND PESOS (₱950,00.00)** is the single/lowest calculated and responsive quotation for the subject procurement.


NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve to declare the quotation of **Clearshot Builders, OPC**, in the amount **NINE HUNDRED FIFTY THOUSAND PESOS (₱950,00.00)** as single/lowest calculated and responsive quotation for the **PROCUREMENT OF VARIOUS CONSTRUCTION MATERIALS AND ELECTRICAL SUPPLIES (Lot 1 or "Supply and Delivery of Ceiling Materials")**, and to recommend to the Head of the Procuring Entity the award of contract to the same contractor/bidder in accordance with the terms and conditions of the Request for Quotation AMP no. 2023-32 and accepted quotation.
