## **RECOMMENDING AWARD OF CONTRACT**

WHEREAS, Purchase Request No. 202303079 (Annex A) was received on 20 March 2023 for the **SUBSCRIPTION TO VARIOUS LOCAL NEWSPAPERS FOR ONE (1) YEAR** with approved budget for the contract in the amount of **THREE HUNDRED TWENTY THOUSAND PESOS (Php 320,000.00)**;

**WHEREAS**, the End-User conducted a market study in which the probable sources were determined and in which it was confirmed that the identified suppliers could undertake the project at more advantageous terms;
