### DECLARATION OF LOWEST CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-050)

**WHEREAS**, Purchase Request No. 202302057 was received on 27 February 2023 for the **SUPPLY AND DELIVERY OF MATERIALS FOR THE GROUND FLOOR LOBBY RENOVATION (LOT 2: BRAND NEW ITALIAN TILES)** with approved budget for the contract in the amount of **SIX MILLION EIGHT HUNDRED FIFTY THOUSAND PESOS (Php 6,850,000.00)**;

**WHEREAS**, the Invitation to Bid and the bidding documents for the Project under Public Bidding No. 2023-015 was posted in PhilGEPS on 28 February 2023 for the abovementioned procurement. The same ITB was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit bids was scheduled on 22 March 2023, 11:00 A.M.;

**WHEREAS**, on or before the deadline, the following contractors/bidders submitted bids with corresponding remarks/rating;

**WHEREAS**, the necessary bid evaluation on 22 March 2023, the bid of MZR Builders was determined and declared as the Lowest Calculated Bid for the Project, and notice was sent requiring the submission of post-qualification documents;

**WHEREAS**, on 31 March 2023 and after post-qualification, MZR Builders was post-disqualified due to the non-compliance of the goods being offered with the minimum technical specifications as evidenced by the provided actual samples;

**WHEREAS**, the bid of Dex-Sal Builders was determined and declared as the Second Lowest Calculated Bid, and notice was sent requiring the submission of post-qualification documents;

**WHEREAS**, on 04 April 2023 and after post-qualification, the bid of Dex-Sal Builders was determined to be responsive to all requirements and established to be compliant with all the legal, technical and financial requirements;

**NOW THEREFORE**, foregoing considered, the Bids and Awards Committee **RESOLVES** the following;


1. to declare the bids of Dex-Sal Builders in the amount of **SIX MILLION EIGHT HUNDRED FORTY-NINE THOUSAND SEVENTY-NINE PESOS AND 55/100 (Php6,849,079.55)**, inclusive of VAT and applicable taxes, as the Lowest Calculated and Responsive Bid for the above-mentioned project;
2. to recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the **SUPPLY AND DELIVERY OF MATERIALS FOR THE GROUND FLOOR LOBBY RENOVATION (LOT 2: BRAND NEW ITALIAN TILES)** under Public Bidding No. 2023-015, be awarded to Dex-Sal Builders.
