### DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

**WHEREAS**, Purchase Request No. 202303085 (Annex A) was received on 21 March 2023 for the **ENGAGEMENT OF A LEARNING SERVICE PROVIDER FOR THE CONDUCT OF SEC ONBOARDING PROGRAM 2.0 MODULE 1: VALUES REFLECTION** with approved budget for the contract in the amount of **One Hundred Sixty Thousand Pesos (Php 160,000.00)**;
