WHEREAS, Purchase Request No. 202303090 (Annex A) was received on 21 March 2023 for the ENGAGEMENT OF A LEARNING SERVICE PROVIDER FOR THE CONDUCT OF SEC ONBOARDING PROGRAM 2.0 MODULE 4: COMPLETED STAFF WORK with approved budget for the contract in the amount of Three Hundred Twenty Thousand Pesos (Php 320,000.00];
