

AGREEMENT



THIS AGREEMENT made the FEB 15 2023 day of _____ 2023 between the **SECURITIES AND EXCHANGE COMMISSION** (hereinafter called "the Entity"), with office address at the SEC Headquarters, Makati Avenue, Salcedo Village, Bel-air, Makati City, represented by Oliver V. Chato, of the one part, and **MICRODATA SYSTEMS AND MANAGEMENT, INC.**, with office address at 199 CM Recto St. cor A. Mabini St. San Juan City, Philippines, represented by Daniel M. Gomez, (hereinafter called "the Supplier") of the other part;

 - (c) Winning bidders' proposal, including the Eligibility requirements, documents and/or statements submitted;
 - (d) Notice of Award of Contract and the winning bidders *conforme* thereto; and
 - (e) Other contract documents that may be required by existing laws and/or the Entity
3. In consideration for the sum of the Contract Price or such other sums as may be ascertained, the Bidder agrees to provide the Project in accordance with his/her/its Quotation.
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Quotation.
