RECOMMENDING AWARD OF CONTRACT**

WHEREAS, Purchase Request No. 202305158 (Annex A) was received on 12 May 2023 for the **ENGAGEMENT OF A LEARNING SERVICE PROVIDER FOR THE CONDUCT OF THE COMPLETED STAFF WORK FOR SEC LEADERS WITH VENUE RENTAL AND CATERING SERVICES** with approved budget for the contract in the amount of **Five Hundred Five Thousand Four Hundred Pesos (Php 505,400.00)**;

WHEREAS, Request for Quotation AMP No. 2023-047 was posted in PhilGEPS on 16 May 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;
