**DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT**

(Resolution No. 2023-069)

**WHEREAS**, Purchase Request No. 202304106 (Annex A) was received on 19 April 2023 for the **CATERING SERVICES FOR THE CONDUCT OF INTERMEDIATE COMPUTER PROFICIENCY LEARNING PROGRAM** with an approved budget for the contract of **NINETY-THREE THOUSAND PESOS (Php 93,000.00)**;

**WHEREAS**, Request for Quotation AMP No. 2023-038 was posted in PhilGEPS on 21 April 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;
