WHEREAS, Purchase Request No. 2023-051-69 (Annex A) was received on 19 May 2023 for **SUPPLY AND DELIVERY OF CURTAIN WALL PANELS AND MOULDINGS** with approved budget for the contract in the amount of **FOUR HUNDRED NINETY THOUSAND PESOS (Php 490,000.00)**;
