



DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-066)

WHEREAS, Purchase Request No. 202301020 (Annex A) were received on 26 January 2023 for the **RENTAL OF 2 UNITS MICROFILM READER/PRINTER MACHINE WIHOUT OPERATOR (Re-Bidding) ["Project"]** with approved budget for the contract in the amount of **One Million Five Hundred Thousand Pesos (Php 1,500,000.00)**;

WHEREAS, the Invitation to Bid and the bidding documents for **RENTAL OF 2 UNITS MICROFILM READER/PRINTER MACHINE WIHOUT OPERATOR (Re-Bidding)** under Public Bidding No. 2023-018 was posted in PhilGEPS on 13 March 2023 for the abovementioned procurement. 1. To declare the bid of Microdata Systems and Management Inc. in the amount of **ONE MILLION FIVE HUNDRED THOUSAND PESOS (₱ 1,500,000.00)**, inclusive of VAT and applicable taxes, as the Single Calculated and Responsive Bid for the above-mentioned projects; and


