RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-086)

WHEREAS, Purchase Request No. 202305179 (Annex A) was received on 26 May 2023 for the **SUPPLY AND DELIVERY OF GENUINE PARTS AND CONSUMABLES FOR DM300C POSTAGE METER** with approved budget for the contract in the amount of **Ninety-Five Thousand One Hundred Twenty-Four Pesos (Php 95,124.00)**;

WHEREAS, the end-user conducted a market study in which the probable source/s was/were determined and in which it was confirmed that the identified supplier is the exclusive/sole distributor of the product/s in the Philippines and could undertake the project at more advantageous terms;

WHEREAS, the Annual Procurement Plan for 2023 provides for Direct Contracting as mode of procurement for the Project in accordance with Section 50 of Republic Act No. 9184 given the determination that the Project can be sourced directly from a specific supplier who exclusively sell or provide the required goods or services in the Philippines;

WHEREAS, in compliance with Section 50 of Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat sent the Request for Quotation (AMP No. 2023-054) to the technically, legally and financially capable supplier, Messaging Solutions Provider Inc. (MSPI), to provide goods/services that are sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the government;


WHEREAS, MSPI submitted its quotation in the amount of **Php 95,124.00** VAT inclusive;


WHEREAS, after verification and validation of all accepted documents (Annex B is Evaluation Report), it was determined that the quotation is responsive for the subject procurement.

NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve recommend to the Head of the Procuring Entity the award of contract to **Messaging Solutions Provider, Inc.**, in the amount of **NINETY-FIVE THOUSAND ONE HUNDRED TWENTY-FOUR PESOS (Php 95,124.00)** for the **SUPPLY AND DELIVERY OF GENUINE PARTS AND CONSUMABLES FOR DM300C POSTAGE METER** in accordance with the terms and conditions of the Request for Quotation AMP No. 2023-054 and accepted quotation.
