

AGREEMENT

THIS AGREEMENT made the 5th day of May 2023 between **SECURITIES AND EXCHANGE COMMISSION** (hereinafter called "the Entity"), with office address at SEC Headquarters, 7907 Makati Avenue, Salcedo Village, Makati City, represented herein by, **OLIVER V. CHATO, ICTD DIRECTOR**, of the one part and the **INFOSTORAGE CORPORATION**, represented herein by **ANSHERINA ROY, AUTHORIZED REPRESENTATIVE**, with office address at 1101 AIC Burgundy Empire Tower, ADB Avenue, cor. Sapphire and Garnet Roads, Ortigas Center, Pasig City, Philippines (hereinafter called "the Service Provider") of the other part;

WHEREAS, the Entity invited Proposals for the Supply, Delivery, Installation, Configuration, Testing and Commissioning of Network Attached Storage ("the Project") and has accepted a Proposal by the Service Provider in the price of *Five Hundred Fifty-Four Thousand Nine Hundred Fourteen Pesos (Php554,914.00)* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - (b) Request for Proposal
 - (c) The Winning Bidder's proposal, including the Eligibility requirements, documents and/or statements submitted
 - (d) Notice of Award of Contract and the Service Provider's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity
3. In consideration for the sum of the Contract Price or such other sums as may be ascertained, the Servicing Agency agrees to provide the Project in accordance with his/her/its Proposal
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Proposal
