

AGREEMENT

THIS AGREEMENT made the _____ day of _____ 2023 between the **SECURITIES AND EXCHANGE COMMISSION** (hereinafter called "the Entity"), with office address at the SEC Headquarters, Makati Avenue, Salcedo Village, Bel-air, Makati City, represented by **FILBERT CATALINO F. FLORES III**, of the one part, and **ACP INTERIOR DECORATIONS SERVICES**, with office address at #1354L Apolinario St., Makati City, Metro Manila, Philippines, represented by **ARISTOTLE PAHUTAN**, (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply, Delivery and Installation of Broadloom Carpet** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **NINE HUNDRED NINETY THOUSAND FOUR HUNDRED PESOS (₱990,400.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - (d) Notice of Award of Contract and the winning bidders *conforme* thereto; and
 - (e) Other contract documents that may be required by existing laws and/or the Entity
3. In consideration for the sum of the Contract Price or such other sums as may be ascertained, the Bidder agrees to provide the Project in accordance with his/her/its Quotation.
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Quotation.
