**WHEREAS**, Purchase Request No. 202305163 (Annex A) was received on 10 May 2023 for the **SUPPLY, DELIVERY AND INSTALLATION OF BROADLOOM CARPET** with approved budget for the contract in the amount of **ONE MILLION PESOS (₱1,000,000.00)**;
