



DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-058)

WHEREAS, Purchase Request No. 202302039 (Annex A) were received on 20 February 2023 for the **LEASE OF COPIER MACHINES FOR SEC HEADQUARTERS AND EXTENSION OFFICES** with approved budget for the contract in the amount of **Three Million Four Hundred Thousand Pesos (Php 3,400,000.00)**;

WHEREAS, the Invitation to Bid and the bidding documents for the **LEASE OF COPIER MACHINES FOR SEC HEADQUARTERS AND EXTENSION OFFICES** under Public Bidding No. 2023-013 was posted in PhilGEPS on 3 March 2023 for the abovementioned procurement. The same IB was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit was scheduled on 24 March 2023;

1. To declare the bid of **UBIX** in the amount of **Three Million Three Hundred Ninety-Six Thousand Six Hundred Pesos (₱3,396,600.00)**, all inclusive of VAT and applicable taxes, as the Single/Lowest Calculated and Responsive Bids for the above-mentioned projects; and
2. To recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the **LEASE OF COPIER MACHINES FOR SEC HEADQUARTERS AND EXTENSION OFFICES** under Public Bidding No. 2023-013, be awarded to **UBIX**.
