### DECLARATION OF SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-092)

**WHEREAS**, Purchase Request No. 202304138 (Annex A) was received on 18 April 2023 for the **SUPPLY AND DELIVERY OF CORPORATE GIFT SETS FOR EXECUTIVES ("Project")** with an approved budget for the contract of **ONE MILLION FIVE HUNDRED THOUSAND PESOS (Php 1,500,000.00)**;

**WHEREAS**, the Invitation to Bid and the bidding documents for **the Project** under Public Bidding 2023-020 was posted in Philgeps on 29 April 2023 for the abovementioned procurement. The same IB was posted on the Securities and Exchange Commission (SEC) website and/or in a conspicuous place inside the premises of the SEC on the same date;

**WHEREAS**, all the mandatory activities before the deadline to submit the bids were undertaken and the deadline to submit was scheduled on 22 May 2023;

**WHEREAS**, on or before the deadline, only the following bidder submitted its bid with corresponding remark/rating;

**WHEREAS**, after the necessary bid evaluation on 22 May 2023, the bid of Tanjer Enterprises was determined and declared as the Single Calculated Bid and notice was sent to the latter requiring the submission of post-qualification documents;


**WHEREAS**, on 30 May 2023 and after post-qualification, the bid of Tanjer Enterprises was determined to be responsive to all requirements and established to be compliant with all the legal, technical and financial requirements;


**NOW, THEREFORE**, foregoing considered, the Bids and Awards Committee **RESOLVES** the following:

1. To declare the bid of **Tanjer Enterprises** in the amount of **One Million Four Hundred Ninety Seven Thousand Pesos (Php 1,497,000.00)**, all inclusive of VAT and applicable taxes, as the Single Calculated and Responsive Bid for the above-mentioned project; and
2. To recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the **SUPPLY AND DELIVERY OF CORPORATE GIFT SETS FOR EXECUTIVES** under Public Bidding No. 2023-020 be awarded to **Tanjer Enterprises**.


