

AGREEMENT


THIS AGREEMENT made the ___th day of June 2023 between the **SECURITIES AND EXCHANGE COMMISSION** (hereinafter called "the Entity"), with office address at The SEC Headquarters, 7907 Makati Avenue, Salcedo Village, Bel-air, Makati City, represented herein by, **EDHONA C. TANTUAN**, SEC Chief Counsel, Office of the Commission Secretary, of the one part, and **TANJER ENTERPRISES**, represented herein by **ANGELICA S. TAN**, authorized representative, with office address at Rm. 1104, Tower B Antel, Seaview Towers, Roxas Blvd. Brgy. 076, Pasay City, Philippines (hereinafter called "the Service Provider") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply and Delivery of Corporate Gift Sets for Executives**, ("the Project") and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Four Hundred Ninety-Seven Thousand Pesos (Php1,497,000.00)** (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) Terms of Reference;
 - (b) Invitation to Bid;
 - (c) The Winning Bidder's proposal, including the Eligibility requirements, documents and/or statements submitted;
 - (d) Notice of Award of Contract and the Service Provider's conforme thereto; and
 - (e) Other contract documents that may be required by existing laws and/or the Entity
3. In consideration for the sum of the Contract Price or such other sums as may be ascertained, the Servicing Agency agrees to provide the Project in accordance with his/her/its bid.
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of reference.
