

AGREEMENT

THIS AGREEMENT made the 23th day of May 2023 between the **SECURITIES AND EXCHANGE COMMISSION** (hereinafter called "the Entity"), with office address at the SEC Headquarters, 7907 Makati Avenue, Salcedo Village, Bel-air, Makati City, represented herein by, **FILBERT CATALINO F. FLORES III**, of the one part, and **GCB KITCHEN FOOD CONTRACTING SERVICES**, represented herein by **GINO VAN VIRNOM LUNA**, authorized representative, with office address at Unit 204 Oasis Hub B, One Oasis Condominium, Ortigas Ave. Ext., Sta. Lucia, Pasig City, Philippines (hereinafter called "the Service Provider") of the other part;

WHEREAS, the Entity invited Proposals for the Catering Services for the Conduct of Capability-Building Program for Accountants: Philippine Financial Reporting Standards (PFRS) Update ("the Project") and has accepted a Proposal by the Service Provider in the price of *One Hundred Eighty-Seven Thousand Two Hundred Pesos (Php 187,200.00)* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (e) Other contract documents that may be required by existing laws and/or the Entity
3. In consideration for the sum of the Contract Price or such other sums as may be ascertained, the Servicing Agency agrees to provide the Project in accordance with his/her/its Proposal
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Proposal
