

AGREEMENT


THIS AGREEMENT made the 5th day of June 2023 between the **SECURITIES AND EXCHANGE COMMISSION** (hereinafter called "the Entity"), with office address at The SEC Headquarters, 7907 Makati Avenue, Salcedo Village, Bel-air, Makati City, represented herein by, **OLIVER V. CHATO**, ICTD Director, of the one part, and **U-BIX CORPORATION**, represented herein by **JOEY A. FRANCISCO**, authorized representative, with office address at 1344 Angono St., Makati City, Philippines (hereinafter called "the Service Provider") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply and Delivery of Printing Services (Re-bidding)**, ("the Project") and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Million Three Hundred Eight Thousand Pesos (Php4,308,000.00)** (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) Terms of Reference;
 - (b) Invitation to Bid;
 - (c) The Winning Bidder's proposal, including the Eligibility requirements, documents and/or statements submitted;
 - (d) Notice of Award of Contract and the Service Provider's conforme thereto; and
 - (e) Other contract documents that may be required by existing laws and/or the Entity
3. In consideration for the sum of the Contract Price or such other sums as may be ascertained, the Servicing Agency agrees to provide the Project in accordance with his/her/its bid.
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of reference.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.




