**WHEREAS**, Purchase Request No. 202302038 was received on 27 February 2023 for the **SUPPLY OF LABOR AND MATERIALS FOR THE PROPOSED RENOVATION AND CONSTRUCTION WORKS AT SEC CAGAYAN DE ORO EXTENSION OFFICE** with approved budget for the contract in the amount of **ONE MILLION ONE HUNDRED THOUSAND PESOS (Php 1,100,000.00)**;

**WHEREAS**, the Invitation to Bid (ITB) and the bidding documents abovementioned project under Public Bidding No. 2023-021 were posted in PhilGEPS on 06 May 2023. The same ITB were posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on the same date;

**WHEREAS**, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit bids was scheduled on 29 May 2023;

**WHEREAS**, on or before the deadline, only NGP CONSTRUCTION submitted its bids with corresponding remarks/rating;
