**RECOMMENDING AWARD OF CONTRACT**

(Resolution No. 2023-097)

**WHEREAS**, Purchase Request No. 202305184 (Annex A) was received on 26 May 2023 for the **SUPPLY AND DELIVERY OF GENUINE TONER BROTHER TN-3478 BLACK** with approved budget for the contract in the amount of **Eight Hundred Forty-Four Thousand Nine Hundred Pesos (Php 844,900.00)**;

**WHEREAS**, the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, also known as the Philippine Government Procurement Act provides under Section 52.1(b) that **Alternative Method of Procurement** through **Shopping** may be resorted to for the:

*"Procurement of ordinary or regular office supplies and equipment not available in the Procurement Service involving an amount not exceeding the thresholds prescribed in Annex "H" of this IRR."*

**WHEREAS**, Request for Quotation AMP No. 2023-055 was posted in PhilGEPS on 02 June 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in the Securities and Exchange Commission's website and/or in conspicuous place inside the premises of SEC on the same date;


**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 02 June 2023, invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;

**WHEREAS**, on or before the deadline to submit quotation/s on 06 June 2023, the following quotations were received and opened (Annex D is Abstract of Quotation):

**WHEREAS**, after verification and validation of accepted proposals (Annex E is Evaluation Report), it was found that the bids of TTCS Trading, Lunarchem Trading, Global Integrated Solutions and Technological Services Inc., and Dona Alejandra Inc. were non-compliant with the technical requirements of the project;


**WHEREAS**, it was also determined that the quotation of **BUSINESS MACHINES CORPORATION** in the amount of **SEVEN HUNDRED NINETY-ONE THOUSAND THREE HUNDRED FIFTY PESOS (₱791,350.00)** is the lowest calculated and responsive quotation for the subject procurement.






