RECOMMENDING AWARD OF CONTRACT FOR THE ENGAGEMENT OF A HIGHLY TECHNICAL CONSULTANT FOR A PERIOD OF FIVE (5) MONTHS

(Resolution No. 2023-095)

WHEREAS, on June 6, 2023, the Office of the Commission Secretary requested, through Purchase Request (PR) No. 202305190, the conduct of the procurement process for the hiring of **Arch. Jose Diego Ramon Maderal** as Highly Technical Consultant to render services for the above-mentioned office/s;

WHEREAS, the Bids and Awards Committee (BAC), after assessment of all documents submitted-*i.e. Terms of Reference, Approval documents, and End-user's justification for the engagement of Arch. Jose Diego Ramon Maderal*, has determined that the above requirement, with an Approved Budget for the Contract (ABC) of Seven Hundred Thousand Pesos (Php 700,000.00), is included in the Supplemental Annual Procurement Plan No. 2023-3 of the Securities and Exchange Commission (SEC);

WHEREAS, **Arch. Jose Diego Ramon Maderal** submitted his proposal together with his BIR Certificate of Registration, PhilGEPS Registration Number, and Signed Curriculum Vitae or Resume;


WHEREAS, the BAC, after evaluation, has determined the proposal and all other documents submitted as acceptable, and that **Arch. Jose Diego Ramon Maderal** is legally, financially, and technically capable to undertake and fulfill the required services; and

NOW, THEREFORE, on the basis of the foregoing, the Bids and Awards Committee **RESOLVES** to recommend to the Head of the Procuring Entity or his authorized representative the award of contract to **Arch. Jose Diego Ramon Maderal** for the **Proposed Construction of the SEC Multipurpose Media Room (Phase 1-Planning and Pre-Procurement)** in the amount of **Seven Hundred Thousand Pesos (Php 700,000.00)** for a period of **five (5) months**, inclusive of VAT and subject to compliance to reportorial requirements as stated in Terms of Reference.


