DECLARATION OF LOWEST CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT (Resolution No. 2023-074)

WHEREAS, Purchase Request No. 2023103091 was received on 27 March 2023 for the **SERVICE AGREEMENT FOR JANITORIAL MANPOWER AND UTILITY SERVICES** with approved budget for the contract in the amount of **THIRTY-SEVEN MILLION ONE HUNDRED THOUSAND PESOS (Php 37,100,000.00)**;

WHEREAS, the Invitation to Bid and the bidding documents abovementioned project under Public Bidding No. 2023-016 were posted in PhilGEPS on 04 April 2023. The same ITB were posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on the same date;

WHEREAS, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit bids was scheduled on 28 April 2023;

WHEREAS, on or before the deadline, only LSERV CORPORATION submitted its bids with corresponding remarks/rating;

WHEREAS, after the necessary bid evaluation on 2 May 2023, the bid of LSERV was determined and declared as the Single/Lowest Calculated Bid, and notice was sent to LSERV requiring the submission post-qualification documents;


WHEREAS, on 17 May 2023 and after post-qualification, the bid of LSERV was determined to be responsive to all requirements and established to be compliant with all the legal, technical and financial requirements;

NOW THEREFORE, foregoing considered, the Bids and Awards Committee **RESOLVES** the following;

1. to declare the bid of LSERV, in the amount of **Thirty-Six Million Seven Hundred Twenty-Four Thousand Two Hundred Seven and 04/100 Pesos (Php36,724,207.04)** inclusive of VAT and applicable taxes, as the **Single/Lowest Calculated and Responsive Bid** for the above-mentioned project; and
2. to recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the **SERVICE AGREEMENT FOR JANITORIAL MANPOWER AND UTILITY SERVICES** under Public Bidding No. 2023-016, be awarded to **LSERV CORPORATION**.


