DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-093)

WHEREAS, Purchase Request No. 202304114 (Annex A) was received on 24 May 2023 for the **SUPPLY, DELIVERY AND INSTALLATION OF TWO (2) UNITS-3 TONNER FLOOR MOUNTED INVERTER TYPE AIR-CONDITIONING UNITS FOR SEC LEGAZPI EXTENSION OFFICE** with approved budget for the contract in the amount of **Three Hundred Seventy-Nine Thousand Pesos (Php 379,000.00)**;

WHEREAS, Request for Quotation AMP No. 2023-053, was posted in PhilGEPS on 24 May 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 29 May 2023 invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;

WHEREAS, on or before the deadline to submit quotation/s- i.e., 01 June 2023, 05:00PM – the following quotations were received and opened (Annex D is Abstract of Quotation):

WHEREAS, after verification and validation of accepted proposals (Annex E is Evaluation Report), it was found out that the bid of Luxenberg Marketing, Inc. was non-compliant with the technical requirements of the project;

WHEREAS, it was also determined that the quotation of Frostworks Refrigeration and Air-conditioning Services in the amount of **Two Hundred Seventy-Four Thousand One Hundred Forty Pesos (₱274,140.00)** is the lowest calculated and responsive quotation for the subject procurement.


NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve to declare the quotation of Frostworks Refrigeration and Air-conditioning Services in the amount of **Two Hundred Seventy-Four Thousand One Hundred Forty Pesos (₱274,140.00)** as lowest calculated and responsive quotation for the **SUPPLY AND DELIVERY AND INSTALLATION OF TWO (2) UNITS-3 TONNER FLOOR MOUNTED INVERTER TYPE AIR-CONDITIONING UNITS FOR SEC LEGAZPI EXTENSION OFFICE** and to recommend to the Head of the Procuring Entity the award of contract to the same contractor/bidder in accordance with the terms and conditions of the Request for Quotation AMP No. 2023-053 and accepted quotation.
