**WHEREAS**, Purchase Request No. 202302052 (Annex A) was received on 21 February 2023 for the **SUPPLY AND DELIVERY OF BROCHURES FOR INFORMATION DISSEMINATION** with approved budget for the contract in the amount of **THREE HUNDRED THOUSAND PESOS (₱300,000.00)**;






