



**DECLARATION OF SINGLE CALCULATED AND RESPONSIVE BID AND
RECOMMENDING AWARD OF CONTRACT**

(Resolution No. 2023-107)

WHEREAS, Purchase Request No. 202306194 (Annex A) were received on 05 June 2023 for the **SUPPLY, DELIVERY, INSTALLATION AND CONFIGURATION OF PRODUCTION AND DEVELOPMENT SERVERS FOR THE IN-HOUSE DEVELOPED SYSTEMS** with approved budget for the contract in the amount of **Seven Million Nine Hundred Two Thousand Five Hundred and 6/100 Pesos (Php 7,902,500.06)**;

WHEREAS, the Invitation to Bid and the bidding documents for **SUPPLY, DELIVERY, INSTALLATION AND CONFIGURATION OF PRODUCTION AND DEVELOPMENT SERVERS FOR THE IN-HOUSE DEVELOPED SYSTEMS** under Public Bidding No. 2023-025 was posted in PhilGEPS on 19 June 2023 for the abovementioned procurement. 




NOW, THEREFORE, foregoing considered, the Bids and Awards Committee **RESOLVES** the following;


