

CONTRACT AGREEMENT


THIS AGREEMENT made the 22nd day of June 2023 between **SECURITIES AND EXCHANGE COMMISSION** (hereinafter called "the Entity"), with office address at SEC Headquarters, Makati Avenue, Salcedo Village, Makati City, represented herein by **HRAD DIRECTOR FILBERT CATALINO F. FLORES III**, of the one part and **HERBIE'S CATERING AND EVENTS OPC**, herein represented by **MR. FLORO I. ABUCEJO**, with office address at 005 Gomez St., Kapalaran Subd., San Juan, Taytay, Rizal, Philippines (hereinafter called "the Supplier") of the other part;


WHEREAS, the Entity invited Bids for certain services, particularly **Catering Services for the Conduct of Comprehensive Intelligence and Counterintelligence Operation Training** ("the Project") and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Hundred Fifty Thousand Pesos (Php450,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Request for Quotation;
 - i. Terms and Conditions;
 - ii. Terms of Reference; and
 - iii. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's quotation, including the Eligibility requirements, and all other documents or statements submitted;
 - iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of the Contract Price or such other sums as may be ascertained, the Supplier agrees to provide the Project in accordance with his/her/its Bid.
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Bidding. *m*
