DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-111)

WHEREAS, Purchase Request No. 202307227 and 202307231(Annex A) was received on 18 July 2023 for the **SUPPLY AND DELIVERY OF VARIOUS COMMON-USE SUPPLIES** with approved budget for the contract in the total amount of **Four Hundred Sixty Thousand Five Hundred Pesos (Php 460,500.00)** for **Items 1, 2 and 3**;

WHEREAS, the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, also known as the Philippine Government Procurement Act provides under Section 52.1(b) that **Alternative Method of Procurement** through **Shopping** may be resorted to for the:

"Procurement of ordinary or regular office supplies and equipment not available in the Procurement Service involving an amount not exceeding the thresholds prescribed in Annex "H" of this IRR."


WHEREAS, Request for Quotation AMP No. 2023-072, was posted in PhilGEPS on 21 July 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 21 July 2023 invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;




