### DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-110)

**WHEREAS**, Purchase Request No. 2023-05-175 (Annex A) was received on 13 July 2023 for **PORTABLE PA SYSTEM, 1 UNIT** with approved budget for the contract in the amount of **SIXTY-SEVEN THOUSAND TWO HUNDRED THIRTY-TWO AND 20/100 PESOS (Php 67,232.20)**;

**WHEREAS**, Request for Quotation AMP No. 2023-70 was posted in PhilGEPS on 14 July 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 07 July 2023, invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;


