DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-106)

WHEREAS, Purchase Request No. 202307216 (Annex A) was received on 10 July 2023, for the **SUPPLY AND DELIVERY OF GENUINE TONER HP W2120X FOR COLOR LASER JET ENTERPRISE M554 PRINTERS OF THE COMMISSION** with an approved budget for the contract of **NINE HUNDRED THOUSAND PESOS (₱900,000.00)**:

WHEREAS, Request for Quotation AMP No. 2023-068 was posted in PhilGEPS on 12 July 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;


WHEREAS, on or before the deadline to submit quotations- i.e., 17 July 2023, 12:00 P.M., the following bidders submitted their quotations:

WHEREAS, after verification and validation of accepted proposals (Annex E is Evaluation Report), it was determined that the quotation of **INTEGRATED COMPUTER SYSTEMS, INC.** in the amount of **SEVEN HUNDRED NINETY-EIGHT THOUSAND FOUR HUNDRED EIGHTY PESOS (₱798,480.00)** is the lowest calculated and responsive quotation for the subject procurement:


