DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-116)

WHEREAS, Purchase Request No. 202308241 (Annex A) was received on 08 August 2023 for the **SUPPLY AND DELIVERY OF VIDEO CONFERENCING EQUIPMENT PACKAGE** with an approved budget for the contract of **ONE HUNDRED SIXTY THOUSAND PESOS (₱160,000.00)**:

WHEREAS, Request for Quotation AMP No. 2023-077 was posted in PhilGEPs on 11 August 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 11 August 2023, invited (Annex C is proof) the legally, technically, and financially capable suppliers;

WHEREAS, on or before the deadline to submit quotations- i.e. 14 August 2023, 12:00 P.M., the following bidders submitted their quotations:



WHEREAS, after verification and validation of accepted proposals (Annex E is Evaluation Report), it was determined that the quotations of Metos Offshore Inc, Avid Sales Corporation and Ulytech Trading were not compliant with one of the requirements in the technical specifications, particularly smart zooming;

WHEREAS, the quotation of **Ynzal Marketing Corporation** in the amount of **ONE HUNDRED THIRTY- FIVE THOUSAND EIGHT HUNDRED PESOS (₱135,800.00)** was determined to be the lowest calculated and responsive quotation for the subject procurement;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve to declare the quotation of **YNZAL MARKETING CORPORATION** in the amount of **ONE HUNDRED THIRTY-FIVE THOUSAND EIGHT HUNDRED PESOS (₱135,800.00)** as the Lowest Calculated and Responsive Quotation for the **SUPPLY AND DELIVERY OF VIDEO CONFERENCING EQUIPMENT PACKAGE** and to recommend to the Head of the Procuring Entity the award of contract to the same bidder in accordance with the terms and conditions of the Request for Quotation AMP No. 2023-077 and accepted quotation.
