WHEREAS, Purchase Request No. 202307238 (Annex A) was received on 02 August 2023, for the **SUPPLY AND DELIVERY OF GENUINE CONSUMABLES FOR JAVELIN J800i ID PRINTER OF THE HRMD-HRAD** with an approved budget for the contract of **ONE HUNDRED SEVENTY-FIVE THOUSAND PESOS (₱175,000.00)**:


