



DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-132)

WHEREAS, Purchase Request No. 202308253 (Annex A) were received on 17 August 2023 for the **PROCUREMENT OF VARIOUS CONSTRUCTION MATERIALS FOR 15th FLOOR RENOVATION** with approved budget for the contract in the amount of **Four Million Nine Hundred Ninety-Two Thousand Sixty Pesos (₱ 4,992,060.00)**;

WHEREAS, the Invitation to Bid and the bidding documents for the **PROCUREMENT OF VARIOUS CONSTRUCTION MATERIALS FOR 15th FLOOR RENOVATION** under Public Bidding No. 2023-033 was posted in PhilGEPS on 25 August 2023 for the abovementioned procurement. The same IB was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit was scheduled on 15 September 2023;

WHEREAS, on or before the deadline, the following contractors/bidders submitted bids for lots 6,7, and 8 with corresponding remarks/rating;



WHEREAS, on 22 September 2023 and after post-qualification, the bids of Marelco, were determined to be responsive to all requirements and established to be compliant with all the legal, technical and financial requirements;

NOW, THEREFORE, foregoing considered, the Bids and Awards Committee **RESOLVES** the following;

1. To declare the bid of Marelco in the amount of **Seven Hundred Eleven Thousand Two Hundred Eighty-Six Pesos (₱711,286.00)**, all inclusive of VAT and applicable taxes, as the Single Calculated and Responsive Bids for the above-mentioned projects; and
2. To recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the **PROCUREMENT OF VARIOUS CONSTRUCTION MATERIALS FOR 15th FLOOR RENOVATION (Lot 6,7, & 8)** under Public Bidding No. 2023-033, be awarded to Marelco.
