**SEC ADVISORY**

**This is to inform the public that 99 DRAGONS PH is NOT AUTHORIZED TO SOLICIT INVESTMENTS FROM THE PUBLIC.**

This Advisory is prompted by the information gathered by the Securities and Exchange Commission (“Commission”) that an identified Team Manager of 99 Dragons PH under the name of a certain **MARIE RYKELL HERNANDEZ** is soliciting investments from the public, which investment is purportedly to be managed by professional traders and asset managers.

**ABOUT 99 DRAGONS**

99 DRAGONS IS A FINANCIAL BUSINESS THAT PROVIDES TRADING SERVICES IN YOUR BROKER'S ACCOUNTS. YOUR ACCOUNT WILL BE OPERATED BY A PROFESSIONAL GROUP OF TRADERS AND ASSET MANAGERS PAYING AN AGREED MONTHLY FEE. THAT FEE WILL BE AUTOMATICALLY DEDUCTED FROM YOUR BROKER'S ACCOUNT IF THE ACCOUNT GETS PROFITS. LET US MANAGE YOUR ACCOUNT AND GET PROFITS AT LAST IN YOUR TRADING AND INVESTMENTS. FEEL THE PEACE OF MIND THAT GIVES HAVING A MANAGED ACCOUNT BY A PROFESSIONAL TRADERS AND ASSETS MANAGER. WE'LL BE GETTING PROFITS FOR YOU WHILE YOU ARE WALKING OR SLEEPING.

**99 DRAGONS PH** likewise offers a Referral Bonus equivalent to 10% of the investment received by the entity from the referrals made by its members.

The investment offering by **99 DRAGONS PH** constitutes solicitation of investments from the public as the investors are enticed to **invest money amounting from Php1,000.00 up to Php1,000,000.00** and in turn such investment will **earn guaranteed profit ranging from 125% to 200% in just 10, 20, and 30 days, respectively**, in violation of Sections 8, 26 and 28 of the Securities Regulation Code (SRC) and Sections 11 in relation to Section 3(f) of Republic Act No. 11765 otherwise known as the Financial Products and Services Consumer Protection Act (FCPA).

In this regard, the public is made aware that, an “*investment contract*,” which is a kind of security, exists when there is an investment or placement of money in a common enterprise with a reasonable expectation of profits to be derived primarily from the efforts of others which is prominent in the scheme of **99 DRAGONS PH**.

As such, the SRC requires that securities must be first registered with this Commission before it can be offered and/or sold to the public and that the concerned entity and/or its agents should have the appropriate registration and/or license to offer and/or sell such securities to the public.

Based on the Commission’s database, **99 DRAGONS PH**, is **NOT REGISTERED** as a corporation or partnership and **OPERATES WITHOUT THE NECESSARY LICENSE AND/OR AUTHORITY** to solicit, accept or take investments/placements from the public nor to issue investment contracts and other forms of securities defined under Section 3 of the Securities Regulation Code (SRC).

Further, the scheme employed by **99 DRAGONS PH** has the characteristics of a “**Ponzi Scheme**” where money from new investors are used in paying “fake profits” to prior investors and is designed mainly to favor its top recruiters and prior risk takers and is detrimental to subsequent participants if new investors become scarce.

The offering and selling of securities in the form of investment contracts using the “**Ponzi Scheme**” which is fraudulent and unsustainable, is **NOT** a registrable security. The Commission will not issue a License to Sell Securities to the Public to persons or entities that are engaged in this business or scheme.

Accordingly, the Commission warns all unscrupulous individuals and/or entities that **strict penalties are imposed for violations of the Securities Regulation Code, the Revised Corporation Code of the Philippines and such other laws, rules and regulations enforced by the Commission.**

Those who act as salesmen, brokers, dealers or agents of **99 DRAGONS PH vis-à-vis MARIE RYKELL HERNANDEZ**, in convincing people to invest in the offered scheme, and those involved in solicitations and recruitment through the internet **may be prosecuted and held criminally liable** under Section 28 of the SRC and Section 11 of the FCPA **both penalized separately** with a maximum fine of Five Million pesos (Php5,000,000.00) or penalty of Twenty-one (21) years of imprisonment, or both pursuant to Section 73 of the SRC (*G.R. No. 195542, 19 March 2014*).

In view thereof, the public is advised **NOT TO INVEST or STOP INVESTING** in any investment scheme being offered by **99 DRAGONS PH vis-à-vis MARIE RYKELL HERNANDEZ** as well as to any other entities having the same or similar schemes and to exercise caution in dealing with any individuals or group of persons soliciting investments or recruiting investors for and on behalf of **99 DRAGONS PH vis-à-vis MARIE RYKELL HERNANDEZ**.
