### DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-145)

**WHEREAS**, Purchase Request No. 202309277 (Annex A) was received on 21 September 2023 for the **SUPPLY AND DELIVERY OF SMART TELEVISION** with approved budget for the contract in the amount of **Eight Hundred Fifty Thousand Pesos (Php 850,000.00)**;

**WHEREAS**, Request for Quotation AMP No. 2023-091 was posted in PhilGEPs on 22 September 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 22 September 2023 invited (Annex C is proof) the legally, technically, and financially capable suppliers;



**NOW, THEREFORE**, we, the members of the Bids and Awards Committee, hereby resolve to declare the quotation of M4Drew Consumer Goods Trading in the amount of **Five Hundred Thirteen Thousand Eight Hundred Sixty-Five Pesos (₱513,865.00)** as lowest calculated and responsive quotation for the **SUPPLY AND DELIVERY OF SMART TELEVISION**, and to recommend to the Head of the Procuring Entity the award of contract to the same contractor/bidder in accordance with the terms and conditions of the Request for Quotation AMP No. 2023-091 and accepted quotation.
