WHEREAS, Purchase Request No. 202309267 (Annex A) was received on 11 September 2023 for the Subscription to Media Production Software Collection with an Approved Budget for the Contract (ABC) in the amount of Five Hundred Sixty Thousand Pesos (Php 560,000.00);
