WHEREAS, Purchase Request No. 202309267 (Annex A) was received on 11 September 2023 for the **Subscription to Media Production Software Collection** with an Approved Budget for the Contract (ABC) in the amount of **Five Hundred Sixty Thousand Pesos (Php 560,000.00)**;

WHEREAS, Request for Quotation with AMP No. 2023-089 was posted in PhilGEPS on 14 September 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;


