DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-142)

WHEREAS, Purchase Request No. 202309269 (Annex A) was received on 15 September 2023 for the **SUPPLY AND DELIVERY OF 15 UNITS WIRELESS TELEPHONE AND 9 UNITS BUSINESS WALKIE TALKIE (INTERCOM)** with an approved budget for the contract of **ONE HUNDRED THIRTY-THREE THOUSAND PESOS (P133,000.00)**:

WHEREAS, Request for Quotation AMP No. 2023-092 was posted in PhilGEPS on 22 September 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 22 September 2023, invited (Annex C is proof) the legally, technically, and financially capable suppliers;

WHEREAS, on or before the deadline to submit quotations- i.e. 27 September 2023, 12:00 P.M., the following bidders submitted their quotations:

WHEREAS, after verification and validation of accepted proposals (Annex E is Evaluation Report), it was determined that the quotations of Maxcore Technologies Inc. and Agile Techfrontier Corporation were compliant with all the requirements;


WHEREAS, the quotation of **Maxcore Technologies Inc.** in the amount of **ONE HUNDRED SEVEN THOUSAND ONE HUNDRED PESOS (P107,100.00)** was determined to be the lowest calculated and responsive quotation for the subject procurement;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve to declare the quotation of **MAXCORE TECHNOLOGIES INC.** in the amount of **ONE HUNDRED SEVEN THOUSAND ONE HUNDRED PESOS (P107,100.00)** as the Lowest Calculated and Responsive Quotation for the **SUPPLY AND DELIVERY OF 15 UNITS WIRELESS TELEPHONE AND 9 UNITS BUSINESS WALKIE TALKIE (INTERCOM)** and to recommend to the Head of the Procuring Entity the award of contract to the same bidder in accordance with the terms and conditions of the Request for Quotation AMP No. 2023-092 and accepted quotation.
