DECLARATION OF LOWEST CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-136)

WHEREAS, Purchase Request No. 202308243 (Annex A) was received on 07 August 2023 for the **SUPPLY AND DELIVERY OF MULTI-PURPOSE PAPER ("Project")** with an approved budget for the contract of **TWO MILLION SIX HUNDRED THIRTY-TWO THOUSAND PESOS (Php 2,632,000.00)**;

WHEREAS, the Invitation to Bid and the bidding documents for the Project under Public Bidding 2023-032 was posted in Philgeps on 18 August 2023 for the abovementioned procurement. The same IB was posted on the Securities and Exchange Commission (SEC) website and/or in a conspicuous place inside the premises of the SEC on the same date;

WHEREAS, all the mandatory activities before the deadline to submit the bids were undertaken and the deadline to submit was scheduled on 18 September 2023;

WHEREAS, on or before the deadline, the following bidders submitted their bids with corresponding remarks/ratings;

NOW, THEREFORE, foregoing considered, the Bids and Awards Committee **RESOLVES** the following:


