WHEREAS, Purchase Request No. 202308253 (Annex A) were received on 17 August 2023 for the **VARIOUS CONSTRUCTION MATERIALS AND ACCESSORIES** with approved budget for the contract in the amount of **Eight Hundred Twelve Thousand Five Hundred Pesos (₱ 812,500.00)**;




