DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-140)

WHEREAS, Purchase Request No. 202308253 (Annex A) were received on 17 August 2023 for the **PLUMBING AND ELECTRICAL FIXTURES AND ACCESSORIES** with approved budget for the contract in the amount of **Nine Hundred Seventy-One Thousand Five Hundred Pesos (₱ 971,500.00)**;

WHEREAS, Request for Quotation AMP No. 2023-94 was posted in PhilGEPS on 22 September 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;
