**DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT**

**WHEREAS**, Purchase Request No. 202308252 (Annex A) was received on 17 August 2023 for the **SUPPLY AND DELIVERY OF VARIOUS FURNITURE FOR THE COMMISSIONER** with approved budget for the contract (ABC) in the total amount of **FIVE HUNDRED EIGHTY-FIVE THOUSAND NINE HUNDRED FORTY PESOS (₱585,940.00)** for **Lots 1,2,3,4;**

**WHEREAS**, Request for Quotation AMP No. 2023-082 was posted in the Securities and Exchange Commission’s website on 17 August 2023 for the abovementioned procurement (Annex B is proof). It was posted in conspicuous place inside the premises of SEC on the same date;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 17 August 2023, invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;


