WHEREAS, Purchase Request No. 202304134 was received on 20 July 2023 for the **SUPPLY AND DELIVERY OF 30 UNITS OF TABLET AND RELATED PORTABLE DEVICES ("Project")** with approved budget for the contract in the amount of **TWO MILLION NINE HUNDRED FORTY THOUSAND PESOS (Php 2,940,000.00)**;

WHEREAS, the Invitation to Bid and the bidding documents for the Project under Public Bidding No. 2023-034 was posted in PhilGEPS on 24 August 2023 for the abovementioned procurement. 


NOW THEREFORE, foregoing considered, the Bids and Awards Committee **RESOLVES** the following;


