WHEREAS, Purchase Request No. 202310290 (Annex A) was received on 04 October 2023 for the **SUPPLY AND DELIVERY OF PLUMBING MATERIALS AND ACCESSORIES** with approved budget for the contract in the amount of **FOUR HUNDRED SEVENTY ONE THOUSAND PESOS (Php 471,000.00)**;


