


CONTRACT AGREEMENT

THIS AGREEMENT made this 20th day of November 2023 between the **SECURITIES AND EXCHANGE COMMISSION** (hereinafter called "the Entity"), with office address at The SEC Headquarters, 7907 Makati Avenue, Salcedo Village, Bel-Air, Makati City, represented herein by **CGFD DIRECTOR RACHEL ESTHER J. GUMTANG-REMALANTE** of the one part, and **JUAN CARLO THE CATERER INC.**, with office address at Brgy. Soro-Soro, Karsada, Batangas City, Batangas Province (hereinafter called "the Service Provider"), herein represented by **MA. KRISTINA E. CARABIDO**, of the other part;

WHEREAS, the Entity invited quotations for certain services, particularly **Food Catering Services for the 10th Corporate Governance Forum** ("the Project") and has accepted a quotation by the Service Provider for the supply of those goods and services in the sum of **Four Hundred Sixty-One Thousand Two Hundred Fifty Pesos (Php 461,250.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Request for Quotation;
 - i. Terms and Conditions;
 - ii. Terms of Reference; and
 - iii. Supplemental or Bid Bulletins, if any.
 - ii. Winning bidder's quotation, including the Eligibility requirements, and all other documents or statements submitted;
 - iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of the Contract Price or such other sums as may be ascertained, the Supplier agrees to provide the Project in accordance with his/her/its quotation.
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
