DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-161)

WHEREAS, Purchase Request No. 202310338 (Annex A) was received on 20 October 2023 for the **CATERING SERVICES FOR AN OFFICIAL EVENT OF THE SECURITIES AND EXCHANGE COMMISSION** with approved budget for the contract in the amount of **Seven Hundred Fifty Thousand Pesos (Php 750,000.00)**;

WHEREAS, Request for Quotation AMP No. 2023-114, was posted in PhilGEPS on October 21, 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;


