### DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-168)

**WHEREAS**, Purchase Request No. 202310280 (Annex A) was received on 9 October 2023 for the **SSL CERTIFICATES WILDCARD (DIGITAL CERTIFICATES SUBSCRIPTION)** with approved budget for the contract in the amount of **One Hundred Sixty-Three Thousand Seven Hundred Twenty-Seven Pesos (Php 163,727.00)**;

**WHEREAS**, Request for Quotation AMP No. 2023-107 was posted in PhilGEPS, in the Securities and Exchange Commission's website on 12 October 2023 for the abovementioned procurement (Annex B is proof). It was posted in conspicuous place inside the premises of SEC on the same date;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 12 October 2023, invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;

**WHEREAS**, on or before the deadline to submit quotation/s 16 October 2023, the following quotations were received and opened (Annex D is Abstract of Quotation):
