WHEREAS, Purchase Request No. 202309273 was received on 26 September 2023 for the **SUBSCRIPTION TO E-MAIL SERVICES ("Project")** with approved budget for the contract in the amount of **THIRTEEN MILLION THREE HUNDRED TWENTY THOUSAND THREE HUNDRED EIGHTY FOUR PESOS (Php 13,320,384.00)**;

WHEREAS, the Invitation to Bid and the bidding documents for the Project under Public Bidding No. 2023-036 was posted in PhilGEPS on 01 October 2023 for the abovementioned procurement. The same ITB was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit bids was scheduled on 23 October 2023, 10:00AM;


NOW THEREFORE, foregoing considered, the Bids and Awards Committee **RESOLVES** the following:


