

DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-028)

WHEREAS, Purchase Request No. 202301007 (Annex A) were received on 26 January 2023 for the SERVICE MAINTENANCE AGREEMENT FOR STORAGE OF MICROFILM ROLLS with approved budget for the contract in the amount of One Million Two Hundred Thousand Pesos (Php 1,200,000.00);

WHEREAS, the Invitation to Bid and the bidding documents for SERVICE MAINTENANCE AGREEMENT FOR STORAGE OF MICROFILM ROLLS under Public Bidding No. 2023-004 was posted in PhilGEPS on 6 February 2023 for the abovementioned procurement. The same ITB was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit was scheduled on 27 February 2022;
