DECLARATION OF LOWEST CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-166)

WHEREAS, Purchase Request No. 202309272 was received on 26 September 2023 for the **SUBSCRIPTION TO MULTIPROTOCOL LABEL SWITCHING (“Project”)** with approved budget for the contract in the amount of **SEVEN MILLION PESOS (Php 7,000,000.00)**;

WHEREAS, the Invitation to Bid and the bidding documents for the Project under Public Bidding No. 2023-037 was posted in PhilGEPS on 01 October 2023 for the abovementioned procurement. The same ITB was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit bids was scheduled on 23 October 2023, 11:00AM;

WHEREAS, on or before the deadline, the following bidders submitted their bids with the corresponding remarks/ratings;

WHEREAS, on 06 November 2023 and after post-qualification, the bid of PLDT Inc., was determined to be responsive to all requirements and established to be compliant with all the legal, technical and financial requirements;

NOW THEREFORE, foregoing considered, the Bids and Awards Committee **RESOLVES** the following:

1. to declare the bid of PLDT Inc. in the amount of **THREE MILLION NINE HUNDRED THOUSAND PESOS (₱3,900,000.00)**, inclusive of VAT and applicable taxes, as the Lowest Calculated and Responsive Bid for the above-mentioned project; and
2. to recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the **SUBSCRIPTION TO MULTIPROTOCOL LABEL SWITCHING** under Public Bidding No. 2023-037, be awarded to PLDT Inc.


